

DBIQ Optimum Yield Indices Selection Report – January 2026

Annual Commodity Weights:

- The Annual selection weights in respect of the DBIQ Optimum Yield Diversified Commodity Index Excess Return (Bloomberg Ticker – DBLCDBCE Index) and the sector indices for the **November** 2025 Annual rebalance are available under Annexure 1.

Intra Year Rebalancing event:

- There are no Extraordinary Commodity Weight Triggers observed for any Single Commodity Index on **02 Jan 2026** (Monthly Observation Date), thus no intra-year rebalancing event will occur.

Single Commodity Indices - Monthly Roll Report:

The report consists of all Single Commodity Indices which are the component indices within the DBIQ Optimum Yield Diversified Commodity Index Excess Return (Bloomberg Ticker – DBLCDBCE Index).

- It lists out the current and new contracts in respect of the Optimum Yield indices which will be rolling in **January 2026**, along with the Roll Yield. For the indices which will not be rolling in **January**, the current contract is listed out.
- The contracts will roll between **05 - January - 2026** and **09 - January - 2026**.
